### 1. Organizational changes

- (1) Outline of organizational changes
  - We restructured our organization at the beginning of the fiscal year in order to strengthen cross-organizational initiatives for the restructuring of the BtoB (wholesale business), one of the key issues of the Revitalize Plan. We will further accelerate organizational integration by combining Garment Group I and Garment Group II.
  - We will combine the Global Trade Group, for which a development policy into the second pillar business was set forth under the Revitalize Plan, and the Melangetop Group into the Global Brand Group. We will strengthen distinct initiatives in the wholesale business for luxury brands and the retail business of golf wear brands, which do not rely on price appeal.
